The CIMTA Inc. hand crafter member business must supply the artistry, talent creativity and expertise critical, essential and integral to the production and quality of their products. They must have creative control of product development; the technical expertise to produce their products and hands on experience in the production of their products. If supplied with basic materials, the CIMTA Inc. handcrafted member must be able to produce their products with quality typical of their items as offered for sale at CIMTA Inc.

Requested documents are for CIMTA, Inc. reference, not for critique of your products. CIMTA, Inc. is a wholesale trade association, and suggests no less than 40% percent discount. Non-handcrafted items offered for sale by any company must be related to the companies product, and must be packaged and labeled with the company name. The business name, and one contact name will be listed in CIMTA's Trade Show Directories. If the business has joint owners, the business should decide who is the contact and voting member. Each business is allowed one vote at the general membership meeting. The business owner member (Member 1 Contact) must participate in at least one of the two annual shows. Member 2 & 3 (Business Associates) should be directly involved in the production of the business products. CIMTA allows three (3) business members to work behind each company exhibit space. As an exhibitor member of CIMTA, Inc. a two night stay is required at the trade show host hotel.
